**STIPULATION AND ORDER FOR DISMISSAL OF
DEFENDANT MAYOR ARCHER OF THE CITY OF DETROIT**

Plaintiffs and Defendants hereby stipulate and agree to the following stipulation and order for the dismissal of Defendant Mayor Dennis W. Archer of the City of Detroit (hereinafter "Defendant Mayor Archer"):

1. Defendant Mayor Archer hereby adopts in whole Certain Defendants' Motion to Dismiss for Lack of Standing and Failure to State Any Claim Pursuant to Federal Rule of Civil Procedure 12(b)(2) and Memorandum in Support of Certain Defendants' Motion to Dismiss Pursuant to Federal Rule of Civil Procedure 12(b)(2), previously filed with the Court on March 10, 2000, a copy of which is attached hereto as Exhibit A.

2. The Declaration of J. Edward Hannan in support of Defendant Mayor Archer's Motion to Dismiss under Fed. R. Civ. P. 12(b)(2) is hereby submitted to establish that the City of Detroit has no contacts in the District of Columbia, attached herewith as Exhibit B.

3. Defendant Mayor Archer hereby adopts in whole Certain Defendants' Motion to Dismiss for Lack of Standing and Failure to State Any Claim Pursuant to Federal Rules of Civil

Procedure 12(b)(1), 12(b)(6) and Memorandum in Support of Certain Defendants' Motion to Dismiss for Lack of Standing and Failure to State Any Claim Pursuant to Federal Rules of Civil Procedure 12(b)(1) and 12(b)(6), previously filed with the Court on March 10, 2000, a copy of which is attached hereto as Exhibit C.


4. On March 14, 2000, the court entered an Order granting the motion to dismiss of defendants Mayors Sills and Harmon under Fed. R. Civ. P. 12(b)(2) for lack of personal jurisdiction and declaring as moot the motion to dismiss of Mayors Sills and Harmon for failure to state a claim upon which relief can be granted under Fed. R. Civ. P. 12(b)(1) and 12(b)(6), attached hereto as Exhibit D.

5. It is hereby stipulated by and between the parties, by and through their undersigned attorneys, that Defendant Mayor Dennis W. Archer of the City of Detroit shall be granted the same relief as defendants Mayors Sills and Harmon. Therefore, the parties hereby agree to this stipulation and order granting Defendant Mayor Archer's motion to dismiss under Fed. R. Civ. P. 12(b)(2) for lack of personal jurisdiction and that judgment on this dismissal may be entered hereon pursuant hereto without further notice as agreed by the parties.


