F.R.APP.P. 42(b) MOTION TO VOLUNTARILY DISMISS CROSS-APPEALS

Plaintiffs-Appellants, MICHAEL MOORE, CHARLES HOOKS, PEGGY FECHTER, JON MAIER, SECOND AMENDMENT FOUNDATION, INC., and ILLINOIS CARRY (hereinafter "Appellants"), and LISA MADIGAN and HIRAM GRAU, Cross-Appellants, pursuant to F.R.App.P. 42(b), hereby move to voluntarily dismiss their respective cross-appeals in this matter. In support thereof, Appellants state as follows:

1. This appeal regards the award of 42 U.S.C. § 1988 fees by the District Court in Case No. 11-CV-3134, which followed this Court's Opinion in 12-1269.

2. Since this appeal was docketed, the parties resolved all matters that were raised in the appeal, including the awarding of Section 1988 fees and the amount of same.

3. The payment of fees and costs has been determined among the parties and is contained in a fully executed Settlement Agreement. All issues regarding the Section 1988 fees, and court costs, has been reduced to judgment in the District Court. Further, all sums have been paid. No additional Order from the Court is necessary.

4. Therefore, the parties contend the subject matter of the appeal is now moot and request these cross-appeals be dismissed, costs to be paid as determined in the parties' Settlement Agreement.
